

Set-Up Fee

One-time Setup Fee	Your account will incur a one-time setup fee when establishing your IRA.	\$50

Quarterly Fees

Custodial Fee (includes 1st asset)	Your account will incur a custodial fee upon account approval and quarterly thereafter. This fee includes the custody of a single asset. If your IRA invests in one asset, then it will be charged \$75 per quarter.	\$75 per qtr.

Additional Asset Custodial Fee	Your account will incur this fee if it holds more than one investment. Your first investment is included in your Custodial fee. Each subsequent investment incurs a \$25 fee per quarter. For example: If your IRA holds 2 investments, then your account will be charged \$100 quarterly.	\$25 per qtr.

Transaction Fees

IRA LLC Setup Fee	Your account will incur a standard \$50 setup fee to establish the IRA and an initial \$50 investment fee to send funds from your IRA to your IRA LLC.	\$100

Investment Fee	Your account will incur this fee each time Madison Trust places an investment on behalf of your IRA. This is applicable to the initial investment, re-investments into the same asset, and any subsequent investments placed. This fee also applies to movement of funds from an IRA to an IRA LLC.	\$50

Cash Disbursement Fee	Your account will be charged this fee when funds leave your IRA for the following transactions: distributions (non-ACH), outgoing transfers to another IRA or qualified retirement plan, and expense payment requests.	\$30

ACH Disbursement Fee	If distributions are taken via ACH (recurring at least quarterly) then your IRA is eligible for our discounted Disbursement fee of \$10.00 per transaction.	\$10

Re-registration of Investment Fee	Your account will be charged this fee when an asset is transferred into or out of your Madison Trust IRA (ex: real estate, promissory notes, convertible notes, private company stock, private placements, minority interest in LLCs, IRA LLCs, etc.)	\$50

Sale of Asset Fee	Your account will be charged this fee when Madison Trust sells an asset on behalf of your IRA (ex: real estate, private company stock, minority interest in LLC, etc.)	\$50

Precious Metals Storage Fee	Your account will be charged this fee when precious metals are deposited into your IRA (by purchase or transfer) and annually thereafter. The \$100 minimum includes your first \$100,000 of metal held at Delaware depository. Beyond that, storage fees are billed at \$1 per \$1,000 of asset value.	\$100 minimum

Account Termination Fee	Your account will incur a termination fee if you close your IRA. This fee will be charged in conjunction with any transaction fees that apply along with any outstanding fees owed.	\$150
